- k) To keep its clubs abreast with respect to Federal, State and Local proposed or enacted rules, regulations and actions that affect them and their members.

**TGCC's web-site** is available to individual members and clubs to inform members of dive trips and activities, as well as of news of interest from around the world. TGCC members, members of TGCC Member clubs, their children and grandchildren can also participate in the **TGCC Memorial College Scholarship Program (MCS)** which is conducted annually. Awards are based upon merit; the value and number of awards are based upon the Council's budget.

**Club Membership Requirements** – Club membership requires approval of the Council. Applying club(s) must submit a copy of their Club's Constitution & By-Laws, a statement that the club is a non-profit organization, that it promotes safe diving practices and holds general member meetings with their club members a minimum of four (4) times a year. Those applying as a "Full Member" club must also annually delegate a Club Representative to attend meetings and vote on that club's behalf, and update a club information form.

## **Definitions of club membership categories:**

- (1) Full member is a voting member and is required to have a properly delegated "representative" attend all Council meetings.
- (2) Affiliate members are non-voting members, normally because they have determined that they cannot regularly attend the TGCC meetings.
- (3) Associate members are non-voting members that are primarily youth or special interest organizations. They do not qualify for the MCS program.
